#### DENVER ENTERPRISE ZONE (DEZ)

- Help increase the economic viability of individuals, families and small businesses and families in Metro Denver through the DEZ.
- Gift of \$250 or more
- Directed to a DEZ program or agency (United for Business)
- Eligible for up to 25% tax credit on state income tax\*
- Tax credits for gifts of stock
- Tax credits associated with any DEZ project may only be taken if the donor files electronically and provides Mile High United Way with their Colorado Account Number (Letter ID)
